The research group of Neurogenetics and Aging of IMBB under in the framework of the Action "Basic Research Financing (Horizontal support for all Sciences), National Recovery and Resilience Plan (Greece 2.0)" funded by the Hellenic Foundation for Research and Innovation (HFRI) (project code: 16399, **GliaAge**) invites applications for two (2) postdoctoral researcher positions.

Job Description: Behavioral and mechanistic studies during neurodegeneration and ageing upon photostimulation in the nematode *Caenorhabditis elegans*

Qualifications: The successful applicant should hold a BSc and PhD in Biology/Biomedicine or related fields, and prior documented experience in molecular/cellular biology methods, modern microscopy techniques. Prior experience in ageing, glia/neurobiology, chemo/optogenetics will be highly appreciated. The successful applicant should also have excellent scientific authoring skills and several scientific publications in peer reviewed journals in related fields and fluency in English.

- Presentation, Communication and Collaboration skills

Evaluation procedure

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.
