**Job Description:** Monitoring neuronal mitochondria fate during ageing and examine the contribution of mitochondria-specific autophagy (mitophagy) in long-term neuron survival.

Qualifications: The successful applicant should hold a BSc in Biology/Biomedicine or related fields, and prior documented experience in molecular/cellular biology methods, modern microscopy techniques. Prior experience in nematodes genetics will be highly appreciated. The successful applicant should also have fluency in English.

Applicants for the post will be selected on the basis of the following criteria:

## **Evaluation procedure**

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.

In case of titles and qualifications awarded by foreign Higher Education Institutions, the provisions of the Law 55/2023 (article 36) and 4957/2022 (article 304) are implemented.

The results of the selection will be announced on the website of IMBB-FORTH.
