### Info about the project:

**MicroBioPest** aims to establish an international research team in Crete, to develop Microbial Biopesticides. IMBB-FORTH, located at Heraklion Crete Greece, is one of the most prominent life science research institutions in Greece, with an outstanding record of scientific achievements, state of the art infrastructure and a broad range of research and innovation activities.

**Job Description:** The successful applicant will work mainly in the insectary and will be responsible for the rearing of insects and perform bioassays. The main insects that will be used are *Aedes albopictus*, *Phlebotomus papatasi*, *Bactrocera oleae* and *Tuta absoluta*. He/she will also participate in writing progress reports and publications. The applicant should be accordingly adaptable and able to work with a range of people in a multicultural environment. Excellent knowledge of English is required.

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.
