Job Description: Study of genetic and dietary intervention with neuroprotective potential during ageing.

Qualifications: The successful applicant should hold a BSc in Biology, Biomedicine, or a related field and be currently enrolled as a student in a PhD program. They should have prior documented experience in molecular biology techniques, microscopy, and C. elegans genetics. The applicant should also possess excellent scientific writing skills, have at least one scientific publication in a relevant field, and be fluent in English.

Applicants for the post will be selected on the basis of the following criteria:

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.

The results of the selection will be announced on the website of IMBB-FORTH. Applicants have the right to appeal the selection decision, by addressing their written objection to the IMBB secretariat within five days since the results announcement on the web.
