The research group of **Christos DELIDAKIS**, under the European Program **HORIZON-WIDERA-2023-ACCESS-02/ Project 101159925** entitled **Building integrative single-cell omics capacities using invertebrate tumour models relevant to human disease – SCENTINEL**, invites applications for one (1) part-time postdoctoral associate.

### About the lab

The Delidakis lab studies cell specification, both normal and pathological, in the context of transcriptional networks and cell signaling in *Drosophila*.

### About the project:

The present project uses cutting edge single-cell genomic approaches to characterize a neural cancer model and its microenvironment in adult *Drosophila* hosts. This will be complemented by microsurgical manipulations, advanced imaging and ex vivo culture. Generation and analysis of cancer models in *Drosophila*/ work package 3 (Deliverable 3.1/ 3.3); Work package 4, exploring complementary technologies (Deliverable 4.3)

### Job Description:

The successful candidate will generate brain tumours by microtransplantation of *Drosophila* tissues and will image them using immunofluorescence and confocal microscopy.

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.
